
Rio Vista Natural Resource Park: Master Planning Update

Linda and Mary of RillitoBend Neighborhood Advocacy Group (RNAG) have been working to develop guidelines and a trail system.

They have begun to partner with Parks and Rec to provide expertise on the water management, ecology, hydrology, vegetation.



Prince Road – Update

The UA School of Landscape Architecture (SoLA) accepted the RillitoBend Neighborhood Association's goals and criteria for the East Prince Road improvements and conducted a Landscape Architecture Studio to develop design proposals for Prince Road from Campbell to Country Club.

Adjunct Professor Travis Mueller's LAR Studio IV class began January 8th. Four teams comprised of three students each presented their proposals on March 4th.

The school recognized the benefit to the community by having the students engage in a design competition, with a cash prize to the winner. An anonymous neighbor donor posted the prize money of \$1,000. The prize is known as the RillitoBend Prize.

A pdf file of the presentations may be seen <u>HERE</u>. Several envision a "Green Spine" along Christmas Wash linking Prince Road and the Loop with a riparian walk skirting the eastern edge of Campus Farm. The winning proposal is entitled, "RillitoBend Urban Agricultural District."

FEMA Green Infrastructure Feasibility Study

In December of 2021 COT flood plain management approached the RilltoBend neighborhood regarding an on-going feasibility study they're working on for a Federal Emergency Management Agency (FEMA) grant to reduce severe flooding issues uphill of our neighborhood in Winterhaven, Specifically, the areas they're focusing on for the FEMA grant are where Christmas Wash flows through the intersections of Ft. Lowell/Country Club; Ft. Lowell/Christmas Avenue along Christmas Avenue and Klendale Road within Winterhaven and at flooding at the intersection of Tucson Blvd/Kleindale Rd.

The study has been on-going for the past year and the conclusion of the study is wrapping up currently in the Spring, 2022.

Spring 2021 - Spring 2022 — FEMA Feasibility Study

Fall, 2022 — FEMA Grant Writing & Application

Summer, 2023 — FEMA Proposed Grant To Be Awarded

2023-2026 (3 Years) — If Selected, Construction Phase Begins



Green Stormwater Infrastructure (GSI)

As a lesser part of the grant to reduce serious flooding, the city is required to implement Green Stormwater Infrastructure (GSI) in the nearby neighborhood area and is offering RillitoBend neighborhood the possibility of implementing a limited amount of GSI in our neighborhood. GSI as defined by the City of Tucson are interventions that use natural or engineered systems to capture, clean and infiltrate stormwater; shade and cool surfaces and buildings; reduce flooding; create wildlife habitat; and provide environmental and community quality of life. In practical terms GSI takes the form of landscaped areas that capture stormwater runoff from the streets, parking lots, and buildings; allowing the water spread out and sink into the soil. In Tucson this is also know as "passive rainwater harvesting."

RBNA Discussions with COT

In a number of meetings with City of Tucson Flood plain manager, Elizabeth Leibold and neighborhood representatives the past 3-4 months and focus group meetings of concerned RillitoBend neighbors and RBNA leadership it has been decided to focus potential GSI work associated with the FEMA grant in the following areas: **Christmas Wash; Prince Road; Cactus Blvd and Allen Road.**

GSI Educational Meetings for private homeowners


Additionally, if there is enough interest - Elizabeth has offered to host a series of free educational meetings for residents of RillitoBend who live in low-lying areas, where rain & stormwater flows may be causing issues on their properties.

All private property homeowners or HOA's are required to pay for and facilitate the implementation of any ideas that result from consultation meetings with Elizabeth and other GSI consultants. These informational sessions are not part of the FEMA grant study or forthcoming proposal but will be offered by Elizabeth and other GSI experts sometime in the future to address issues raised by residents that may not have been included in the selected areas.

Treat Ave to Cactus Blvd HAWK crossing

As of May 2022

- Bike project should start construction around May 23rd for the Treat Bikeway starting at the southern end of the route.

TEP Kino to DeMoss-Petrie 138 Kilovolt Transmission Line

TEP is seeking to amend the Gateway and Scenic Routes code of the City of Tucson so as to allow the construction of tall overhead transmission lines in places along those routes, which are now prohibited. A group called the Tucson Underground Coalition is seeking an alternative to the above-ground plan.

Several public meetings with the City of Tucson Planning Commission have been held. RBNA is posting information on those meetings when they are announced.


