Neighborhood Enhancement

We continue to pursue ways we can increase safety, manage stormwater, create habitats and beautify our neighborhood. Here are a few projects that we have been working on.

Prince Road

Larry Bird is leading a neighborhood coalition with representatives from Winterhaven, Richland Heights East and RillitoBend to improve our section of Prince Road—Country Club to Campbell Avenue—for pedestrian access, transit/bus shelters, landscaping and drainage. The City's MOVETucson has in its transportation plan requested RTA [Regional Transportation Authority] to move our project into Tier 1. Currently RTA has our section of Prince Road as Tier 2, but the City is on our side. Note: Tier 1 projects have higher priority and need to be completed before starting Tier 2 projects.

Cactus Blvd: Rain Garden at Rancho Morado

After two good summer monsoon seasons, the rain garden at Rancho Morado has been established. The boulders (purchased and delivered thanks to Ward 3 Office) have protected the area from vehicles, and the rock dams and swales built by the volunteer team, under the guidance from Catlow Shipek of Watershed Management Group, have captured and created robust vegetation and habitats. Neighbors weed and mow the area as it's a work in progress.

Allen Road: Rain Garden at Meadow View

In November 2020, neighborhood volunteers planted native trees and pollinators along the north wall of Meadow View on Allen Road. Now the once-barren stretch has been replaced with over 60 native plants including velvet mesquite and ironwood trees. The soaking monsoon rains have helped to establish these plants and many native wildflowers and grasses have begun to take root and expand the plantings. Thank you, Paula Dasko of Meadow View and neighbor Catlow Shipek, and all the volunteers who water and maintain the garden.

Green Water Infrastructure (GSI)

Earlier this year, Elizabeth Leibold, COT engineer, reached out to us about the opportunity to submit a proposal about improving our neighborhood through GSI, as part of their grant proposal to FEMA. Our neighborhood is in the Christmas Wash watershed, and the City is focused on managing stormwater in the Christmas Wash. Matthew Vasquez headed up the efforts. Our report highlighted four areas of the neighborhood that would benefit from GSI: Christmas Wash "Green Spine", East Prince Road, East Allen Road and North Cactus Blvd. We should be hearing from Elizabeth soon, so stay tuned!



Rio Vista: Master Planning Update

Our Queen By Murray DeArmond

When we moved here, nearly 50 years ago, we were surprised to see a skeletal plant full of white flowers hidden behind an ancestral mesquite tree, located in the back parts of our property near our chicken coop. Even though the sweet-smelling flowers were spent after just one day, the plant was so unusual and spectacular, we decided to move it to a more visible location in order to better keep track of the bloom cycle the following year. When our younger son and I dug around the base of the plant to initiate the transplantation, we soon learned an important lesson. We began to uncover an enormous tuber. the likes of which we had never seen before. Fortunately, we replaced the soil and abandoned the job. It was good decision as we later learned that these tubers, like huge turnips, can be enormous and weigh up to 100 pounds! Through all these years, the above-ground plant hasn't changed a lot. All but one day of the year, the plant looks

History Corner

Many are aware of the significant artistic heritage of our neighborhood, but fewer are aware of the people behind the equestrian heritage. Most notable is the original owner of Gentleman's Acres, Colonel Cedric Errol Fauntleroy. Born in Mississippi in 1891, he was an ace pilot in World War I, serving with Eddie Rickenbacker's 94th fighter squadron. In addition to earning the Cross of Valor four times, Fauntleroy volunteered later in the war to serve in Poland, earning the rank of Colonel and receiving Poland's highest military decoration.

Upon returning to the states, he was a quite successful businessman, first living in Chicago and later New York. Sadly his wife and the eldest of his two daughters were killed in plane crashes.

Colonel Fauntleroy retired and moved to Tucson in 1951 where he lived until his death in 1963. It was here in our neighborhood he established Gentleman's Acres as a family farm for breeding and raising thoroughbreds and quarter horses for racing. The farm consisted mostly of pasture land, about 25 acres. It included a race (and practice) track which was located in the mostly "open" area of the western part of what is now Rio Vista Natural Resource Park.

Charles and Jean Bagley bought Fauntleroy's farm in 1965 and continued to call it "Gentleman's Acres." They built permanent stalls and runs, and they soon began to board and train horses, caring for up to 60 horses. In 1987, the City bought several pieces of land (making up what would be designated as Rio Vista Natural Resource Park), including 13 acres from the Bagleys.

Rich and Sandy Young bought the property in 2019 from Jean and renamed it the Hitching Post Ranch at Gentlemen's Acres. They continue to operate it as a boarding facility, as well as upgrading and maintaining the southern portion of Rio Vista for equestrian exercise and training use.

like dead, burnt sticks coming out of the ground. Our Queen has faithfully bloomed one night each year since we've lived here.

One evening we were driving home and heard on AZPM that Tohono Chul was initiating a public celebration of the Queen's appearance in their gardens. We had been following the progress of ours, and didn't think it close to blooming. After we returned home, we checked and, to our surprise, it was also in full bloom. How these plants can bloom on the same, single night out of the year remained a mystery to us. Our neighbor suggested a phenomenon called quantum entanglement might help to answer the question.

For a number of years, we had a small ritual celebration of the annual bloom. Neighbors and friends get together; sometimes we read the legend; sometimes we toast the Queen; and always we are amazed at this desert miracle.
